Youth Accounts are for family members between the ages of 16 and 22. This account is a great way to teach young family members financial responsibility. They can have the benefit of a full-service account, with no monthly fees, no minimum balance requirement (interest bearing with a balance of \$200 or more), checks at no charge once a year and a Debit Card that functions the same as an ATM card. The Debit Card can be used to pay for purchases as a debit or credit card anywhere MasterCard® is accepted, and the funds are deducted directly from their share draft account.
